1. information about the collection of personal data

In the following we inform you about the collection and use of personal data within the framework of contracts concluded with us in the context of our business operations.

3. collection and storage of personal data as well as type and purpose of their use

The following information is collected by us and stored until automated deletion:

When an order is placed, the following personal data will be collected, stored and processed by us:

- Name, first name
- Address
- Telephone and fax number
- email address
- Bank data, IBAN, BIC
- Tax number, value added tax ID and commercial register number
- Membership of a purchasing association

The data mentioned will be processed by us for the following purposes

- for the handling of the transactions concluded with you contracts
- for advertising purposes, provided that a relevant consent has been given.

The legal basis for data processing is on the one hand Art. 6 para. 1 sentence 1 lit. b GDPR, insofar as the data collection concerns the execution of the contract as such. The legal basis for the processing of data for advertising purposes shall be in accordance with Art. 6 Paragraph 1 Sentence 1 lit. a GDPR on the basis of your voluntarily given consent.

The stored personal data will be deleted if the data processing is based exclusively on your consent pursuant to Art. 6 para. 1 lit a GDPR, if you revoke your consent to storage, furthermore, if the knowledge is no longer required for the fulfilment of the purpose pursued with the storage or if the storage is inadmissible for other legal reasons.

4. transfer of data to third parties

A transmission of your personal data to Third parties will only take place if

- a passing on of your personal data is permitted by law and pursuant to Art. 6 para. 1 sentence 1 lit. b GDPR and is necessary for the processing of the contractual relationship with you,
- there is a legal obligation to pass on data pursuant to Art. 6 para. 1 sentence 1 lit. c GDPR.



- the disclosure according to Art. 6 Para. 1 S. 1 lit. f GDPR is necessary for credit assessment or for insurance within the framework of the existing framework credit insurance and there is no reason to assume that you have an overriding interest worthy of protection in not disclosing your data. FRANK GmbH regularly carries out such a credit check when concluding contracts and in certain cases where there is a legitimate interest. In the latter case, insurance will also be taken out within the framework of the existing framework credit insurance. FRANK GmbH cooperates with the Atradius Kreditversicherung, branch of the Atradius Crédito y Caución S.A. de Seguros y Reaseguros, Spanien – Opladener Straße 14, 50679 Köln from which we receive the necessary data. For this purpose, we send your name and contact details to the Atradius Crédito y Caución S.A. branch in Germany.

5. rights of data subjects

- Right to object to the processing,
- Right to data transferability.

6. right of objection

Insofar as the processing of your personal data is based on legitimate interests in accordance with Art. 6 Para. 1 S. 1 lit. f GDPA, you have the right, pursuant to Art. 21 GDPA, to object to the processing of your personal data if there are reasons for doing so which arise from your particular situation or if the objection is directed against direct advertising. In the latter case, you have a general right of objection, which is implemented by us without stating a particular situation.
